Exhibitors Area

The exhibition area will have three service zones, on which the service points will be distributed. Each service point has an ice bucket, wine glasses, a spitting bucket, an identification and other materials supplied by the organization.

Each exhibitor may request one or more service points. Each service point may have up to two persons and can have up to 6 different bottles / references of sparkling wines.

Each service point may be shared by two different exhibitors, since the total number of bottles / references doesn't exceed the total six, which is the limit.

By the end of the event, each exhibitor should deliver the materials supplied. Any damages or no returns will be charged:

- Wine Glass: 6,00€ +VAT
- Spitting Bucket: 20€ +VAT
- Table Identification: 25€ +VAT
- Ice bucket: 50€ +VAT

The service point will be decorated by the organization, and the use of roll-ups or other materials are not allowed. The exhibitor cannot have flyers or brochures on the table, but can deliver by hand to the visitors.

On check-in, exhibitors will receive the credentials for the two elements (or one in case of shared point) registered on the application form.

Additional wine glasses may be required, but will be charged at 6,00€ +VAT.

The organization will supply ice for the refrigeration, along the event, by the means necessary.

This event does not allow local direct sales.

Invitations

Each exhibitor will receive 5 invitations (free entrance) for each service point requested (2 invitations on shared service points per exhibitor). Additional invitations may be requested, for 8€ +VAT each.

Tickets

The event is public, and may be accessed by anyone with a ticket or an invitation. The ticket will cost 20€ (VAT included) and includes a sparkling wine glass. The organization reserves the right to change this price at any time without any previous notice.

Application

To formalize this event application, the exhibitor should print and fill the form. Signing the form implies the agree with this regulation. The form should be send by email or by letter.

The participation is subject to availability, and validated after the payment is confirmed. The inscriptions payment can be made by bank transfer at the order of ivinum, unipessoal Lda, IBAN: PT50.0036.0121.99100052798.64 (BIC MPIOPTPL). The proof of bank transfer payment must be send with the inscription form.

For the companies that participated in the Brut Experience Competition, the event participations costs are 190€ +VAT for each service point, or 95€ +VAT for each shared service point until June 15, and 240€ +VAT for each service point or 145€ +VAT for each shared service point afterwards.

For the companies that did not participated in the Brut Experience Competition, the event participations costs are 240€ +VAT for each service point, or 145€ +VAT for each shared service point until June 15, and 290€ +VAT for each service point or 195€ +VAT for each shared service point afterwards.

The registrations will be closed when full.
